1. Proposal to change the charter

Brian McCarthy spoke to the delegates and raised the issue regarding the elections where three officer positions were being voted on this year. 5. Distribution and acceptance of 2015 General Assembly minutes

Dana Burduja, President called for the acceptance of the 2015 General Assembly minutes. Votes were cast and 28 members accepted the minutes. 14 members indicated that they were abstaining from voting due to the fact that they were not present at the meeting. No member disapproved of the minutes.

6. PCSI schools

Jeff Hatcher spoke about the forthcoming "winter" school (the school for advanced design and implementation of casemix funding models) and explained that they are planning to go ahead with the school. He indicated that it is important for the school to have local help in the country the school is being held in. Dana Burduja appealed to the members to register for the conference and indicated that the school will be run at a loss based on the current numbers. Jeff and Dana outlined the historical VAT issues in relation to the school which can be surmised as "Vat must be charged in the country the school is held in based on the rules of that country". Dana also noted that courses in France (where the organization was formed and is based) are VAT free. Finally, Jeff indicated that 22 people attended the school in Lisbon and they made a small surplus.

Following this, Jeff Hatcher spoke about the Canadian school which is to be held in January 2017. This is a school offered by CIHI for Canadian students which has a similar syllabus to the "winter" school and is under the auspices of the PCSI. He indicated that it is heavily subsidised and there is waiting list for people to take part in the course. Dana Burduja added that students who take part in the Canadian school become members of the PCSI organisation. Finally, Dana indicated that PCSI is open to conducting other customised training courses if other organisations and countries approach them.

Dana Burduja spoke about the situation regarding the "summer" school () where the school was cancelled due to low numbers. She indicated that it has been advertised already for 2017 and that people should indicate that they would like to attend as early as possible. (before 15/04/2017). She also noted that this school include a French track where the course was conducted via French.

Later in the discussion, Jean Marie Rodrigues re-iterated the information on the "summer" school. He indicated that the school was cancelled and that a number of

registrations did not arrive in time (they arrived later in the month). He proposed that for the next school, people can indicate their interest in the school from mid November 2016 to the start of April 2017. He then indicated that the school would contact people who expressed an interest mid April 2017.

7. Future conferences

Dana Burduja outlined that it is planned to hold the 2017 conference in Sydney. She indicated that IHPA will take the full financial risk which is greatly appreciated by the PCSI as it helps to keep the price low.

She indicated that there is no proposal for a place/ partner to organise the 2018 PCSI conference. This was discussed at the EC and the possibility of the holding the conference every two years. It was also decided that the EC would look for a partner country in a proactive way and it would be expected that this would be a European country. She asked for suggestions and indicated that Inek in Germany could not get involved.

8. Hardship fund

Dana Burduja outlined that it is planned to update the PCSI policy on the hardship fund. It is planned to prioritise participation at the conference and it is also planned to expand the hardship fund to middle income countries (from low income counties). The new hardship fund rules will be put on the website when ready.

9. Closing accounts and the acceptance of the 2015 Financial report

Paula Monteith, Treasurer, presented the 2015 Financial Report, as follows:

 - Projection assumes PCSI Winter School 2016 incurs loss of 11,500 euros to be paid via the French Chequing account.
 - Bank charges are estimated for October to December 2016 inclusive (includes foreign transaction fee) of 150 euros.

The following points/discussions were made regarding the accounts.

- Paula and Dana went through the assumptions for the projection.
- Dana indicated that the figures for the summer school will change as there are additional costs regarding the school.
- She also indicated that there would not be a cost for the abstracts system this year. The current system is a 3 year contract with an annual payment. PCSI is looking at a free alternative for the next conference after Sydney.
- Paula indicated that the there was a payment for the cancelled summer school relating to a non-refundable payment made by a student.
- Marios Petrides asked about the difference in expenditure between the two schools. Dana indicated that this relates to the fact that there are additional costs which have not been claimed from the summer school. Paula also indicated that the costs in locations are different for the different schools as is the cost of getting to the locations.

Paula asked for the vote on the accounts. 36 delegates accepted the accounts, no delegates abstained and the no delegates objected to the accounts. The accounts were passed by the general assembly

10. Change to the length of office for Executive Officers.

Brian McCarthy addresses the meeting and presented the proposed change to the statues of the organization as discussed in the full session.

7.4 Elected individuals, whether they are Officers or members to serve on the Executive Committee, will have terms spanning three years with the exception of where the executive committee has temporally reduced the term and where the reduction is voted and accepted by the General Assembly. Every term reduction must be voted in the General Assembly

He asked for a vote on this proposal. The result was 36 delegates accepted, 0 abstained and 0 rejected the proposal. The proposal was accepted by the general assembly.

11. Other Business/Items for Discussion

There were no other issues raised and consequently the meeting was closed.
