

PCSI School - Advanced Design and Implementation of Case-Mix Funding Models

November 7 – 11, 2016

Nicosia, Cyprus

School Details

Target Audience

The School is intended for individuals with a role in the development of health policy, design of funding models, or the management of a hospital or health insurance organisation, and who have prior experience in the case-mix field, or have previously attended PCSI's school 'Introduction to Principles and Applications of Case-Mix in Health Systems'.

School Objectives

The school will provide students with solid and comprehensive expertise in the design, implementation and monitoring of casemix funding mechanisms. Topics covered will include casemix system design, patient-level costing, calculation of cost weights and price setting, setting of activity targets, outlier flagging, exception payments, monitoring and evaluation, analytical techniques, and hand-on analysis of data.

School Dates and Times

The School will take place from Monday November 7 to Friday November 11, 2016. Class hours will be from 9:00 a.m. to 5:00 p.m. from Monday to Thursday and 9:00 a.m. to 12:45 p.m. on Friday.

School Location

The School will take place in Nicosia, Cyprus at the Hilton Cyprus Hotel.

School Syllabus

The School covers the following topics:

- The various mechanisms of case-mix funding (e.g. population, case-mix based budget allocations, activity-based funding) and their applications in regional allocations, funding of physicians, hospitals, and long-term care;
- The role of clinical information, financial information, case-mix systems and cost weights, as foundations of case-mix funding;
- Funding model design (i.e., price setting, activity targets, outlier payment, and incentives), and implementation (i.e., regulation, data requirements, monitoring and evaluation);
- Analytical techniques and data analysis applied to the funding and management of health services.

Teaching Format

The School uses a case-study method, along with instructor presentation and panel sessions, to deliver theory and provide practice with concepts. Small and large group discussions are used throughout the week, encouraging opportunities for networking and learning from instructors and peers.

School Instructors

Instructors are international experts in health economics and policy, and the design and implementation of case-mix, costing, and hospital funding systems.

Admission Criteria and Other Details

- 1. Ability to work and study in english;
- 2. Prior exposure to one or more case-mix applications in current or past employment, or prior attendance at PCSI's Summer School;
- 3. Basic familiarity with statistical distributions, statistical tests, and statistical analysis including linear regression;
- 4. You are required to bring your own laptop with a word processor application such as Microsoft Word, a spreadsheet application such as Microsoft Excel, and a presentation application such as Microsoft Powerpoint;
- 5. Student's admission to the school will be based on their experience and projected impact on their work. The maximum number of students that will be accepted is 24;
- 6. Enrolment from any one institution/organization may be limited to three students based on demand.

Within 5 days of receipt of your application, the school will notify you as to whether or not your application has been accepted.

Tuition Fee

The tuition fee for the school is 1700 euros per person, including VAT. Tuition fee payment is due within 21 days after you are notified that your application has been accepted. Details for payment will be provided.

Hardship Fund

Applicants who meet school admission criteria but cannot attend due to financial reasons may wish to apply to the PCSI Hardship Fund for a subsidization of the school tuition fee. To be eligible for this financial assistance the applicant must be a full time student (proof is required), or from a 'low income country' as defined by the World Bank.

The PCSI Hardship Fund has limited funds. The number of students and the portion of their

tuition fee that will be subsidized will be decided upon by the PCSI President. Only in rare cases will the subsidy be 100% of the tuition fee. Travel and accommodation expenses are not supported by the Hardship Fund.

Meals and Breaks

Lunch will be provided. Tea, coffee and other light refreshments will also be provided during coffee breaks.

Students are responsible for their own breakfasts and dinners.

Social Activities

Each day after classes end, PCSI will organize and host a casual and optional get-together for a couple of hours at a local cafe or bar (a different location each day). This will provide students and instructors with an opportunity to unwind, get to know one another, and experience a little bit of Lisbon.

Refunds and Cancellations

A full refund of school tuition, less 10% administrative charge, will be made for cancellations received in writing at least one month prior to the school. Cancellations made by a student less than one month prior to the school are non-refundable.

In the unlikely event of unforeseen circumstances causing the school to be cancelled, PCSI's liability is limited to a refund of student tuition. PCSI recommends that when planning travel to Lisbon and accommodations in Lisbon as part of attending the school, students should inquire on the cancellation policy of any airline or hotel that they are considering, and ensure that they are comfortable with these cancellation policies. PCSI also recommends that students have adequate insurance to cover any travel or personal expense claims.

Travel to Nicosia

Students are responsible for arranging and for the cost of travel to and from the school. The <u>Cyprus tourism website</u> may be helpful in planning your trip. As advised on the <u>transportation</u> <u>page</u> (click on the airports link), visitors should fly into either Larnaca or Pafos airport. Visitors should not fly into Ergan airport.

Information on visa and other travel documents required to enter Cyprus can be found by <u>clicking here</u>. Students are responsible for ensuring that they have all necessary documents required to enter Cyprus. Upon request the school will provide you with a letter of invitation for visa application purposes.

Information on attractions in Cyprus can also be found on tripadvisor (<u>Cyprus</u>, <u>Nicosia</u>, <u>Larnaca</u>, and <u>Ayia Napa</u>).

Air and sea temperatures are quite pleasant in Cyprus in November.



Accommodation

Students are responsible for arranging and covering the cost of their accommodation during the school.

A block of rooms is being held at the <u>Hilton Cyprus Hotel</u>, where the school will be held. The rates are as follows:

Standard room, single occupancy: €110 per room per night, including breakfast Standard room, double occupancy: €130 per room per night, including breakfast Executive room, single occupancy: €160 per room per night, including breakfast Executive room, double occupancy: €180 per room per night, including breakfast

A pool view is an extra €10 per night Meal supplement (lunch or dinner) is €27.00 excluding drinks.
